A pre bid meeting of the Procurement committee was held on September 12th 2023 at 1130hrs at the project Management unit for Khyber Pakhtunkhwa for Integrated Tourism Development Project (KITE) Department of Tourism (DoT).

The participants of the meeting were welcomed by the procurement expert PMU KITE DoT, and inform that the Government of Khyber Pakhtunkhwa has received credit of US dollar 70 million from International Development Association (IDA) of the World Bank Group for Khyber Pakhtunkhwa Integrated Tourism Development Project (KITE) and intends to apply part of the proceed towards payment under the contract for " Conservation & Preservation Work of Archaeological Sites Damaged by Recent Flood" And the instant procurement is carried out in accordance with the request for bids RFB method set out in the World Bank recruitment tribulation recruitment in investment project financing work, non-consultant and consulting services (July 6th 2016 revised November 2017, August 2018 and November 2020) following the national market approach.

The advertisement and Issued request for building documents which were already made available on the project website <u>www.kite.kptourism.com</u> were briefly explained in the twirling points were discussed in explanation to the queries raised by the contractor were provided and agreed.

Bid Validity	The Bid shall be valid until 120 days as of the deadline for Bid submission as specified in the Section-II BDS ITB 18.1
Bid Security	The Bid Security amounting to PKR. 200,000 % shall be submitted against Bid Cost in local currency and shall be in shape of Bank Guaranty, Pay order or Call Deposit Receipt from any scheduled bank of Pakistan on the name of Project Director, PMU KITE DoT against each Lot. No other instrument will be accepted as specified in Section-II BDS ITB 19.1.
Performance security	The successful bidder shall submit the irrevocable an unconditional bank security 10% (8% as Performance Security and 2% as Environmental and Social (ES) Performance Security) of the accepted contract amount issued by a schedule Bank of Pakistan. as specified in Section-II BDS ITB 48.1 and 48.2.
Currency	The currency of the bid will be PKR Park Rupees as mentioned in ITB 32.1 of the bit data sheet.
